

Public Council Meeting

Town of Truro Monday, May 3rd, 2021 – 1:00 p.m. Virtual Meeting via Zoom

A regular Public Meeting of Truro Town Council took place virtually on Monday, May 3rd, 2021 at 1:00 p.m. via Zoom.

1. APPROVAL OF AGENDA

Mayor B. Mills noted an amendment to the agenda with the addition of the following items: 4 d (comments from residents regarding the proposed extended closure of Louise Street) and 10 e (letter to Council from Kathleen MacPherson regarding the potential re-zoning of 125/135 Willow Street).

On motion of Councillors C. Hinton and A. Graham, the Agenda was approved as amended. Motion carried.

2. APPROVAL OF MINUTES

On motion of Councillors J. Flemming and B. Thomas, the Minutes for the Public Council Meeting on April 12th, 2021 were approved as circulated. Motion carried.

3. MOTIONS AND NOTICE OF MOTIONS - N/A

4. **PETITIONS AND DELEGATIONS**

a) Public Hearing – 64 Ford Street, Development Agreement

On motion of Deputy Mayor W. Talbot and Councillor A. Graham, it was moved that Council approve the request by Wendell Thomas to enter into a Development Agreement permitting a 4-storey, 19-unit residential development on lands including 64 and 50 Ford Street and adjoining lands as described in staff's final report, subject to the submission and approval of a Traffic Impact Statement, Storm Water Management Plan and Landscaping Plan. Motion carried.

b) Public Hearing – 215 Queen Street, Development Agreement Amendment

There was discussion on the responsibility of the damaged tree roots relating to this development. CAO M. Dolter advised he would seek the legal opinion of the Town's solicitor. It was also suggested that the Developer consider a higher fence and the residents of Logan Street be consulted. CAO M. Dolter indicated this would be brought forward to the Developer.

On motion of Councillor B. Thomas and Deputy Mayor W. Talbot, it was moved to approve the application by Arkham Developments Limited to amend a March 2016 Development Agreement relating to lands at 215 Queen Street to permit one (1) additional dwelling unit, add additional lands, revise timing provisions, remove phasing requirements, and update plans. Motion carried.

c) Variance Appeal – 185 Kaulback Street

The Appellant was in attendance and stated the reasoning for the appeal, that being, the proposed structure would block out the sun, especially during January and February after having invested in making his home energy efficient.

A Shadow Study was presented to Council by the Developer along with information on the affordable housing program that would be utilized for this project.

On motion of Councillors J. Flemming and A. Graham, it was moved to uphold the decision of the Development Officer to grant the variance in relation to Building "B" on lands at 185 Kaulback Street. Motion carried.

d) Proposed Extended Closure of Louise Street - Comments from Residents

Council heard from Dave Connors on behalf of The Blunt Bartender, Gregor Archibald, Marc and Bev Sheeran, and David McKillop who all voiced their concerns around the proposed extended closure of Louise Street to accommodate the Nook & Cranny's outside patio request. The request for decision took place later in the meeting and is noted below under 'New Business' as item 10 d.

8. **QUESTIONS BY MEMBERS**

Councillor B. Thomas inquired about the status of the deer demonstration garden. Director of Parks, Recreation & Culture A. Simms indicated that the Horticulturist is reviewing, and staff will bring forward to Council in due course.

Councillor J. Barnard presented a motion for staff to amend the Municipal Planning Strategy (MPS) and the Land Use Bylaws (LUB) within 60 days. After discussion, Council agreed and unanimously voted to table this item for the next Public Meeting to allow staff time to discuss internally as this is a huge undertaking that would take at least eight (8) months, if not longer, to complete.

10. **NEW BUSINESS**

a) Lyme Disease Proclamation & VON Week Proclamation

Mayor B. Mills read a Proclamation proclaiming May 2021 as Lyme Disease Awareness Month in the Town of Truro.

Mayor B. Mills also recited a Proclamation declaring the week of May 23rd, 2021 – May 29th, 2021 as Victorian Order of Nurses (VON) Week in the Town of Truro.

b) Request for Decision: 60 Golf Street, Set Public Hearing Date

Councillor C. Hinton proposed the tabling of this item to the next Public Meeting; however, it was determined this would not be in accordance with the Municipal Government Act (MGA).

On motion of Councillor J. Flemming and Deputy Mayor W. Talbot, a Public Hearing date for June 7th, 2021 has been established to consider approval of a multi-unit residential development consisting of one 8-storey building containing 76 dwelling units on lands at 60 Golf Street, PID No. 20452892. Motion carried.

c) Request for Decision: Appointment of Residential Building Inspector

On motion of Councillors J. Barnard and C. Hinton, it was moved to appoint Avery Withrow as Residential Building Official of 1- and 2-unit, group C buildings, accessory buildings, and decks covered under the Nova Scotia Building Code Act Part 9. Motion carried.

d) Request for Decision: Nook & Cranny Request, Extended Closure of Louise Street Much discussion took place on this request.

Initially, a vote revealed 4-3 against the motion, however, after a misunderstanding, Councillor A. Graham advised her vote was not accurate and requested that the motion be re-read, and a new vote take place.

The new vote revealed 4-3 in favor of the following motion: be it resolved that the Town of Truro agrees to enter into an Agreement with 3279889 Nova Scotia Limited under similar conditions to the Agreement of 2020 with the following provisions: Louise Street to remain open as a one-way street with traffic diverted to Prince Street via the parking lot, no outside live music permitted, the driveway/path to the Marigold Cultural Centre remain open and a full review and consultation of the agreement take place by July 31st, 2021. Motion carried.

e) <u>Letter from Kathleen MacPherson: Potential Re-Zoning of 125/135 Willow Street</u> CAO M. Dolter read the letter submitted to Council by Kathleen MacPherson on behalf of Willow Street Neighbors and Friends relating to the potential re-zoning of 125-135 Willow Street.

Director of Planning J. Fox indicated that there is no current development application in progress. Any updates relating to this request will be posted to the Town's social media.

Council acknowledged receipt of the letter and awaits next steps.
